Dear Brothers and Sisters:

We are pleased to offer the members of International Brotherhood of Electrical Workers Local 160 a new method for to pay their monthly dues – automatic debit. You can have your payment made automatically from your checking or savings account. And, you do not have to change your present banking relationship to take advantage of this method.

Making your dues payment through the automatic debit method is convenient for you in many ways:

- Saves time – fewer checks to write
- You can make your contributions even if you are on vacation or out of town
- Easy to sign up for

How does the automatic debit work?

You authorize regular payments to be made from your checking or savings account by International Brotherhood of Electrical Workers Local Union 160. Your payment will be made automatically on one of the two days you specify. And proof of payment will appear on your statement. The authority you give to charge your account will remain in effect until you notify us in writing to terminate the authorization. Automatic debits are dependable, flexible, convenient, and easy. To take advantage of this method to make your dues payment, complete the attached authorization form and return it to the Local Union 160 office.

Please Note: Before you can take advantage of this, you must be current on your union dues. If you are in arrears, please call for the specific amount you owe Local 160 and then mail a check to 13220 County Road 6, Plymouth, MN 55441.
