TO ALL 'A' MEMBERS

There are still so many IBEW Local 160 members that don't realize that there is a small pension and death benefit with the International Brotherhood of Electrical Workers.

For example: All members under the Mo Valley contract have two (2) pensions and their annuity. You have the IBEW pension which is at \$4.50 per years of service, NEBF which is at \$32.00 per years of service and NEAP.

Any IBEW member may be an 'A' member if you so wish to. The dues are currently \$18.00 more per month than the 'BA' members.

If you would like more information on the 'A' membership benefits and how it works, feel free to contact me at the hall and I will be more than happy to sit and explain everything to you.

RIGHT TO WORK THREAT

With Minnesota surrounded by Right To Work States it is a must to get the word out on the importance and urgency of the Right To Work Threat that unions in Minnesota face. Here are some of the issues, that are important yet often overlooked by those buying union printing.

When working with a union printing company (or a company in any industry) be sure to ask:

- If the company is union, what local(s) represent the employees. This is a simple yet very important question to ask.
- Do they perform all of the work with their union employees? If they don't where do they send the work? If a union printing company subcontracts with another union printing company then the company doing the actual printing is required to have their own union label on the work, not the label from the company sending the work.
- If the work is going to be sent out to another printing company, ask where it is going. You have the right to know where it's going and you should ask because if it is going to a shop in a "Right To Work" state pull the job and find a printing company in Minnesota that can do the work!
- Some union print buyers work with brokers and there is no reason to do that, especially in Minnesota. Brokers may not only send the work to a "Right To Work" state with the goal to increase their profit margin and charge you more, but, also, brokers are notorious for sending work to non-union shops that use counterfeit or illegal union labels. If you must use a broker, ask to see the union label from the printing company doing the work and check with the printing union local offices to ensure that the label is legit.
- If you are active or involved in political or issue-based campaigns, please insist that those in charge of the effort use legitimate union printing companies in Minnesota. It's sad but true that a number of Minnesota elected officials use union printing companies in Wisconsin, Iowa, Illinois, Maryland, etc. and don't support the union workers that support them AND can vote for them!
- The cost of sending union work to "Right To Work" states is real and directly impacts union workers. For example if a Minnesota political campaign (that wants union endorsement) or local union in Minnesota that spends about \$210,000 in a year in Wisconsin or Iowa on their printing displaces one Minnesota union printing employee. That's one union employee that could have (should have) voted for the candidate that supports unions. That doesn't include the revenue loss and impact to mailing companies, paper and ink vendors, etc. But the question is: Even though the candidate is seeking union/labor endorsement does that candidate really support unions/labor if he/she sends their printing, and possibly other services, to Right To Work states?
- The Right To Work Threat is more pressing and immediate than it has ever been in the history of unions. Minnesota is now an island, surrounded by Right to Work States and we need to seal up the borders to keep union work in Minnesota and to keep the Right To Work advocates out!
- If there are any questions as to who is doing the work, insist on a plant or facility visit to see firsthand the employees and equipment that should be doing the work. If the vendor hesitates or doesn't want you to visit, that should be a very strong hint that they are not a legitimate union vendor for your project.

Bottom line is: Keep work in Minnesota! Use legitimate union vendors whenever possible. Do your due diligence to ensure that they are legitimate and to address the questions/issues listed above. Spread the word about legitimate union vendors and really spread the word about vendors that are not legitimate.

When you've been through an unexpected change, the old you dies and a new one is born. And therefore you must allow yourself to be a baby. Get emotional and moral support any way you can. Give yourself a limited time each day (about an hour or so) to focus on the adjustment. And don't make big decisions until you've got your legs under you. You don't even know who the new you will grow up to be, so postpone large commitments, giving yourself time and love. Everything else will take care of itself.
